LIMITED POWER OF ATTORNEY FOR
SECTION 16 REPORTING OBLIGATIONS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, Hubertus Muhlhauser, hereby appoints each of Stephen D. Lupton and Lynnette D.
