LIMITED POWER OF ATTORNEY FOR
SECTION 16 REPORTING OBLIGATIONS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, GARRY L. BALL, hereby appoints each of Stephen D. Lupton and Lynnette D.
